- We may use photographs for marketing purposes where consent has been given in the contract.

HOW LONG WE RETAIN YOUR DATA

For users that contact us through the website (if any), we store the personal information they provide in their user profile. All users can see, edit, or delete their personal information at any time. Website administrators can also see and edit that information. Data will be held no longer than required for client relationship period but no longer than 7 years
